<u>Updates to the Men's and Women's International Match Calendars</u>

Dear Sir or Madam,

The COVID-19 pandemic has negatively affected football competition at all levels across the world. From the onset, FIFA has highlighted health as being the absolute priority and has supported the suspension of domestic and international competition wherever required.

As a result and in order to address the consequences of this exceptional situation, FIFA established the COVID-19 FIFA-Confederations Working Group, which immediately set about working on the updates to the Men's and Women's International Match Calendars necessitated by this disruption. Alongside this, FIFA also regularly consulted with professional football stakeholders, taking into account their views and feedback.

The result of this process has seen the FIFA Council and the Bureau of the Council take several decisions over the past months regarding changes to the Men's and Women's International Match Calendars, the most recent of which were approved by the Bureau of the Council on 14 August 2020. These decisions reflect the fact that the sanitary situation differs between regions, and a one-size-fits-all calendar is therefore not feasible given the differences between each Confederation during this unique period.

Summary of decisions taken regarding the Men's International Match Calendar:

International window of September 2020

- For the AFC, CAF, Concacaf, CONMEBOL and the OFC, the international window of September 2020 is postponed to January 2022 (24 January – 1 February 2022). This means that there is no mandatory release of players for Member Associations from these Confederations in the context of Annexe 1 of the Regulations on the Status and Transfer of Players for the international window of September 2020
- For UEFA, the international window of September 2020 is maintained. FIFA is in close contact with UEFA, as the competition organisers for the games planned in September 2020. • Based on the above as well as the current sanitary situation, it was also agreed that requests from non-European Member Associations to play friendlies in Europe with European-based players during the international window of September 2020 can unfortunately not be accepted

International windows of October and November 2020

• For UEFA, the international windows of October and November 2020 are exceptionally extended by one additional day, allowing for 3 games to be played instead of 2 games (as an exception to art. 1 par. 4 of Annexe 1 of the Regulations on the Status and Transfer of Players)

International window of June 2021

• The international window of June 2021 is extended by 7 additional days for the AFC, CAF, Concacaf and the OFC, allowing for 4 games to be played in this window

International window of January 2022

• This window, which is a result of the postponement of the international window of September 2020, is applicable for the AFC, CAF, Concacaf, CONMEBOL and the OFC but not UEFA. The dates are the following: 24 January – 1 February 2022

Confederation final tournaments

- CAF: inclusion of the Africa Cup of Nations (AFCON) in January 2022 (exact dates to be confirmed) with an exemption to Annexe 1, art. 1 par. 6 of the Regulations on the Status and Transfer of players to allow players to participate in both the AFCON and the FIFA World Cup™ in 2022
- Concacaf: inclusion of the new dates for the Gold Cup of 2 July 1 August 2021, with the obligatory release period starting on 28 June 2021
- CONMEBOL: inclusion of the new dates for the Copa América of 11 June 11 July 2021
- UEFA: inclusion of the new dates for the EURO of 11 June 11 July 2021

Summary of decisions taken regarding the Women's International Match Calendar:

All Confederations

- Finalisation of 7-15 June 2021 as the dates for the Type I window
- Inclusion of the new dates for the Women's Olympic Football Tournament of 21 July 6 August 2021



All Confederations except UEFA

- Cancellation of the 14-22 September 2020 Type I window
- Finalisation of 7-16 June 2021 as the dates for the Type II window
- Extension of Type I window (13-21 September) to include a Type III window of 13-25 September to replace the Type III window originally scheduled for June 2021

UEFA:

Inclusion of UEFA in the blocked period for final championships of the confederations of 4 July – 7
August 2022
